

**Chlortetracycline Turkey Feed – AUREO<sup>a</sup> - Bluecomb**  
**Type C Medicated Complete Feed**  
(chlortetracycline Type C medicated feed)

Caution: Federal law restricts medicated feed containing this veterinary feed directive (VFD) drug to use by or on the order of a licensed veterinarian.

For control of complicating bacterial organisms associated with bluecomb (transmissible enteritis, coronaviral enteritis) susceptible to chlortetracycline in turkeys.
