

Chlortetracycline Breeding Sheep Feed - AUREO^a
Type C Medicated Complete Feed
(chlortetracycline Type C medicated feed)

Caution: Federal law restricts medicated feed containing this veterinary feed directive (VFD) drug to use by or on the order of a licensed veterinarian.

For reducing the incidence of (vibronic) abortions caused by *Campylobacter fetus* infection susceptible to chlortetracycline in breeding sheep.
